- If you receive DIRAUX issued orders for lodging, you are required to pay the \$20.00 registration fee. Otherwise, you do not pay the registration fee.
  - Your guest does not have to pay the registration fee.
  - If required, you must include the \$20.00 registration fee with this form. The fee can be reimbursed as "Registration Fee" on your orders.
  - If you receive DIRAUX issued orders for lodging, you are required to stay at the Scottsboro Hampton Inn and need to make your own hotel reservations no later than April 15, 2010. Please identify yourself as part of the "District Search and Rescue, Coast Guard Auxiliary" to get the government rate.
  - If you are receiving reimbursable orders you are required to attend the Awards Banquet on Saturday night.
